

**AN ORDINANCE TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCES OF THE CITY OF NEW BRUNSWICK
TITLE 10, "VEHICLES AND TRAFFIC"**

BE IT ORDAINED by the City Council of the City of New Brunswick, as follows:

SECTION I

Title 10, Chapter 10.20, Section 10.20.010 - Schedule 39, "Parking Zones for Handicapped Persons" is hereby amended to **ADD** the following:

| <u>STREET</u> | <u>SIDE</u> | <u>LOCATION</u> |

| 7 Lufberry Avenue #P1505859 | Northeast | Beginning at a point 80' from the northeasterly curblineline of Curtis Place and extending northwesterly along the northeasterly curblineline of Lufberry Avenue to a point 23' thereof. |
| 207 Howard Street #P1558762 | Southeast Side of Lee Avenue | Beginning at a point 60' from the northeasterly curblineline of Howard Street and extending northeasterly along the southeasterly curblineline of Lee Avenue to a point 23' thereof. |
| 29 Louis Street #P1554732 | Northeast | Beginning at a point 150' from the southeasterly curblineline of Somerset Street and extending southwesterly along the northeasterly curblineline of Louis Street to a point 23' thereof. |
| 177 Lawrence Street #P1019897 | Northeast | Beginning at a point 240' from the northwesterly curblineline of Remsen Avenue and extending northwesterly along the northeast curblineline of Lawrence Street to a point 23' thereof. |
| 317 Sandford Street, Apt. 2 #P1322186 | Northeast | Beginning at a point 100' from the southeasterly curblineline of Railroad Avenue and extending southeasterly along the northeasterly curblineline of Sandford Street to a point 23' thereof. |

SECTION II

SEVERABILITY:

If any subsection, paragraph or provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, such finding shall not affect the remaining provisions hereof which shall remain in full force and effect.

SECTION III

REPEALER:


All ordinances inconsistent with the provisions of this Ordinance are repealed to the extent of such inconsistency.




