

**AN ORDINANCE TO AMEND AND SUPPLEMENT ORDINANCE O-021503 ENTITLED, "AN ORDINANCE FIXING THE SALARIES AND WAGES OF VARIOUS EMPLOYEES, OFFICIALS OF THE CITY OF NEW BRUNSWICK, PROVIDING FOR THE MANNER OF PAYMENT," AND REPEALING ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT HEREWITH**

**BE IT ORDAINED**, by the New Brunswick City Council, New Jersey as follows:

**SECTION I**

Section II of said Ordinance O-021503 as amended, is further amended as follows:

A. The following titles are amended to reflect salaries fixed by the Mayor of the City of New Brunswick:

<u>TITLE</u>	<u>RANGE NUMBER</u>	<u>SALARY RANGE (2016)</u>
1. Director of Policy and Economic Development	96	\$66,000 - \$134,000
2. Confidential Secretary	91	\$38,000 - \$74,000
3. Water Treatment Plant Superintendent	95	\$56,000 - \$116,000

B. Attachment B is amended to adjust Range 97 and Range 98 for years 2016 and 2017:

	\$78,000 - \$178,000	2017
<b>RANGE 98</b>	\$88,000 - \$185,000	2016
	\$89,000 - \$188,500	2017

**SECTION II**
