**BE IT FURTHER RESOLVED**, that this annual notice be filed with the City Clerk of the City of New Brunswick, and that it be posted on an appropriate bulletin board in the lobby of City Hall, 78 Bayard Street, New Brunswick, New Jersey, and that it be transmitted to the newspaper of record for the City of New Brunswick, namely, THE HOME NEWS TRIBUNE, and that it be available to the public for a fee of Five Cents (0.05¢) per copy; and
